

## PROCESSING GARNISHMENTS AND SUBPOENAS

## Summary

As an employer, Kelly Services is legally bound to respond timely to subpoenas requesting personnel or payroll information and administer all garnishments (legal deductions) related to Kelly employees. Failure to do so can result in Kelly being legally liable for court fines, missed payments or for the entire debt. If a garnishment order was sent to your branch and not forwarded, this liability will be charged to your branch.

Types of mandatory legal deductions include:

- Garnishment A court-ordered deduction for an unpaid debt to a creditor
- Tax lien An order for payment of back taxes
- Child support A court-ordered deduction for the support of a minor
- Student Loan A court-ordered deduction for unpaid student loans

**Note:** Bankruptcy invalidates all previous court-ordered deductions, although new ones can be added after the bankruptcy takes effect.
